B.A., LL.B.(HONS.)

CENTRE FOR POST GRADUATE LEGAL STUDIES (CPGLS)

At NMIMS KPMSOL, the LL.M. programmes are offered under the aegis of the CPGLS. The Centre is established to offer advanced and interdisciplinary teaching, learning and research opportunities in law for post-graduate students, thereby creating an intellectually stimulating academic environment with highly qualified, experienced and dedicated faculty members committed to provide an excellent legal education. Our one- year LL.M. degree follows the guidelines for introduction of this course as per the UGC guidelines of 2012. The University follows an Assurance of Learning (AOL) model that focuses on outcome based education designed through Bloom's taxonomy and content delivered uniformly across all campuses of NMIMS. The one-year LL.M. programme is developed to impart Indian and global perspectives in following specialization.

Eligibility

- A candidate should have passed the qualifying examination of Bachelor of Laws – Three-year LL.B. programme or LL.B. programme five-year Integrated course with minimum 50% marks (or equivalent cumulative grade point index)
- Candidates who have appeared for the final year examinations may also apply. Candidates who have cleared their graduation by doing a part-time course or through distance learning, correspondence courses, externally, open-school from a recognized University are eligible to apply and register as per UGC guidelines.

We aim to provide placements to the well-deserving graduates and postgraduate students by providing assistance from the placement committee throughout their law school journey.

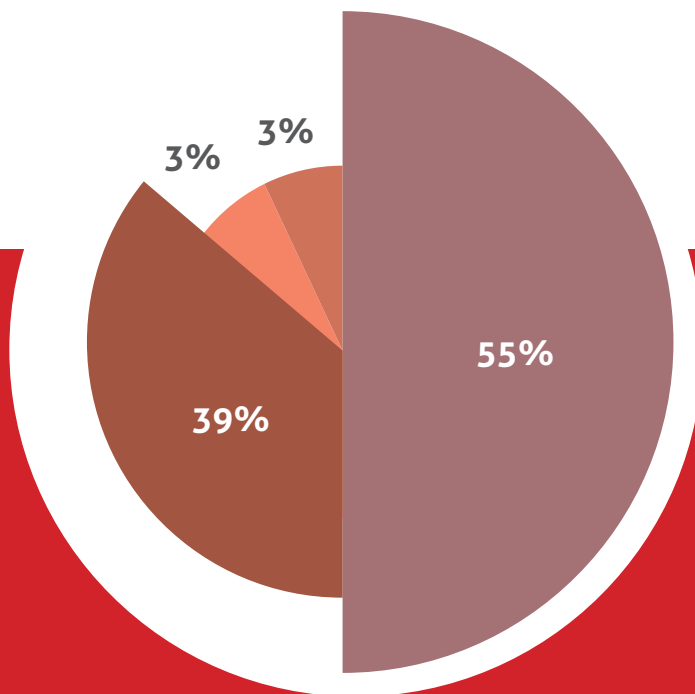

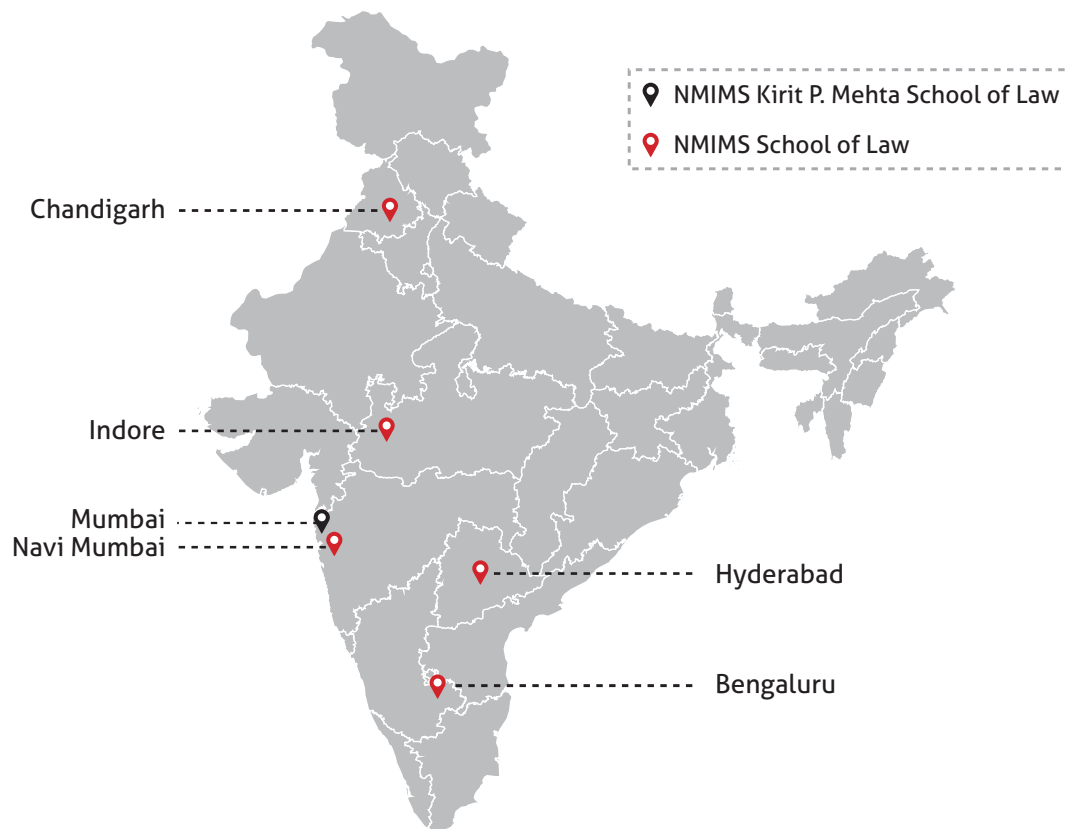
